The ESG and sustainability reports are part of domestic regulations, while the EU Taxonomy, CBAM, and CSDDD introduce new expectations from international regulators. ESG is no longer just an empty acronym; it has become a comprehensive framework that encourages every CEO to conduct a thorough due diligence of their company's operations. The first session of the conference focuses on ESG criteria in financing, risk management in practice and reporting, ratings, investor attitudes, compliance, and expectations.
